**Voters are required to provide an approved form of identification at the polling place before they may receive and cast a ballot.** Pre-registration, for this election, will close on Friday, May 22, 2020 at 5:00 P.M. It is highly recommended that those persons wishing to vote in this election pre-register on or before the May 22, 2020 deadline. Voters who are not pre-registered or who have changed precincts may also be required to provide proof of residence. The following documents can be used as proof of residency if they are current to within 45 days of submission and contain your name and current address: residential lease, utility bill, bank statement, paycheck, government check or other government document. Any voter who cannot show ID may have their identity attested to by another registered voter in the precinct who has proper ID.

To request an absentee ballot, please use the official form available at the Delaware County Auditor's Office, the county website at [www.co.delaware.ia.us](http://www.co.delaware.ia.us) or at the Secretary of State's website located at [www.sos.state.ia.us](http://www.sos.state.ia.us) and send it to the Delaware County Commissioner of Elections, 301 E. Main St., Room 210, Manchester, Iowa 52057. The last day to request an absentee ballot to be sent to you by mail is Friday, May 22, 2020 at 5:00 P.M. In-person absentee voting is available at the Delaware County Auditor's Office thru 5:00 P.M. on Monday, June 1, 2020. The Auditor's Office will be open on Saturday, May 23, 2020 from 10:00 am until 2:00 pm and Saturday, May 30, 2020 from 8:00 am until 5:00 pm for absentee voting. You may track the progress of your absentee ballot by following the link available on both the County's and Secretary of State's websites.

All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle.
