General Fund - Increase in required funding due to renovations of Courthouse Annex (old Community Savings Bank), purchase of furnishings for new Sheriff's Dept/Jail, renovation of old Sheriff's Dept and Courthouse Offices, increase in employee wages Rural Services - Increase in required funding due to increase in amount being transferred to Secondary Roads for maintenance to county roads, increase in employee wages
